Most of our sites have resumed research activities and are able to recruit new patients, remote activities are encouraged whenever possible, and the show goes on! This bulletin will feature the continued impacts of the crisis on our study as well as provide some general updates.

Featured Personnel:

Randy Luciano, MD, PhD has been a nephrologist at Yale University School of Medicine for the last 7 years. Dr. Luciano completed his residency and fellowship training at Yale. Prior to that, he studied at Wake Forest University in North Carolina for his undergraduate studies, at New York University for his PhD graduate work in biomedical sciences, and at University of Connecticut where he earned his medical degree.

Dr. Luciano is an active clinical nephrologists seeing patients most days of the week, either inpatient, in his dialysis units, or in one of his outpatient clinics. He is especially interested in the role of the kidney biopsy in



diagnosis and prognostication of kidney disease. Apart from TRIDENT where Dr. Luciano serves as the site PI, he is also involved in KPMP (through the NIDDK) and collaborates with a Yale Professor in Laboratory medicine obtaining extra cores to validate a mutli-photon microscope in the clinical setting. His other area of interest is establishing and expanding a glomerular clinic at Yale.

Updates on Research Activities due to Covid-19:

- Active recruitment. All sites that have resumed recruitment activities, should be sure to inform the DCC; this information will be updated on ClinicalTrials.gov.
 Sites are encouraged to follow their local clinic guidelines with regard to resumption of research activities and new recruitment.
- Use of Remote Consent. If needed, the use of remote consent is allowed due to the impacts of Covid-19. This is approved for all relying sites, non-relying sites will need to seek local approval for the use of remote consent. See below for guidance on the use of remote consent:
 - Ensure patient has a printed copy of the ICF (mail or email); review details of ICF together with patient.
 - If patient agrees to participate, patient signs the ICF and returns signed copy to site (site personnel to sign and date). Patient will also need to send proof of the signed document (photo, scan, fax, etc.) for immediate documentation of obtaining consent.
 - o A Note to File is written by site to document the remote consent process.
- Research Visits should be conducted with limited in-person patient
 contact. Labs and physical measures require_the patient to come into the clinic,
 however in order to reduce patient-staff contact, other elements of the research
 visits that can be completed remotely should be done so. This includes medical
 updates, concomitant medications, and medical history survey.
- Tracking Visit Activity and Documenting Deviations. Please continue to track visits that are incomplete or completed remotely due to Covid-19 and document these under the Deviation Reports CRF.

- A monthly review of active sites' recruitment and enrollment progress including changes due to the Covid-19 pandemic;
- Data QC plans and timeline;
- Study project data updates including but not limited to RNA sequencing, urine single cell and pathology analysis;
- Review of possible ancillary studies and new projects;
- Discussion of new protocol and study design changes.
