### Ambulatory Transformation Working Groups

### eCheck-in Smilow Ambulatory

Starting Monday, July 20th, all Smilow Ambulatory Clinics will go live with eCheck-in. Patients using MyChart will have the opportunity to use the eCheck-in functionality, allowing the patient to complete some of the tasks that are required during a patient appointment electronically and up to three days prior to the scheduled visit.

- Specific options within the eCheck-in process include: verifying demographics, updating medications, confirming allergies, reviewing problem list, completing a COVID screening, and completing a co-payment, if necessary. Implementing eCheck-in aligns with other YM and YNHHS ambulatory sites.
- Thank you to the Smilow Cancer Hospital Care Centers in Guilford and Torrington for piloting the eCheck-in process.
- Concurrent with the implementation of eCheck-in, we are streamlining the medication reconciliation process. For patients who do not use eCheck-in, the MA or ACA will update the medication history directly in EPIC, eliminating the paper medication list.

### **Department of Medicine COVID Explorer**

The aim of the COVID Explorer (DOM-CovX) database is to provide ready access for Yale researchers to summary statistics and rapid visualizations of aggregated clinical data in order to generate hypotheses for further data requests, grant submissions, and scholarly work.

- The database currently includes all patients admitted for hospitalization to the 6 delivery networks of the Yale New Haven Health System with a positive COVID test during their hospitalization. Patients admitted to the Yale Health System who have opted out of electronic health record research are NOT included in the dataset or any collaborator datasets. As of today, there are 2,913 patients included.
- Data presented in the DOM-CovX Data Explorer may differ from data from other datasets or dashboards published by groups from Yale or YNHH. Firm conclusions should not be made from these aggregate data and we encourage researchers and clinicians to use these tools for hypothesis generation to prompt further, more detailed analyses.
