Needs assessment: Celiac disease remains undiagnosed in a significant proportion of individuals and several studies have shown that there has been a significant change in the epidemiology and clinical presentation of celiac disease over the years. A mismatch in the results of various serological tests can result in diagnostic dilemmas. Additionally, significant proportion (estimated 10%-30%) of patients with celiac disease do not respond to the gluten free diet [Nonresponsive celiac disease (NRCD)] and require further work up in order to identify the cause of NRCD. A better understanding of these issues could help in bridging the clinical gaps in caring for patients with celiac disease. Objectives: Recognize the changing prevalence, epidemiology, and clinical presentations of celiac disease; Assess the utility of commonly used antibody tests in the diagnosis of celiac disease and choose the most appropriate combination of tests to confirm or rule out the diagnosis of celiac disease; Identify various potential causes of non-response to therapy with the gluten free diet and recognize and treat the underlying cause of NRCD.
