"Hemolytic Anemia as a Mechanism for Vasculopathy and Pulmonary Hypertension in Sickle Cell Disease and Other Hemolytic Conditions"

NEEDS ASSESSMENT:

Hemolytic anemia occurs in a variety of clinical entities including Sickle Cell Disease. Our understanding of the role of molecules released from red blood cells undergoing hemolysis has evolved significantly over the past decade. In order to optimally care for patients with hemolytic conditions, there is a need for physicians to understand the pathophysiologic process as a basis for complications associated with hemolytic states such as sickle cell disease, malaria, and other conditions.

LEARNING OBJECTIVES:

At the conclusion of this activity, participants will be able to:

*Explain how hemolytic anemia results in the release of erythrocyte Damage Associated Molecular Pattern molecules (eDAMPs) that cause vascular dysfunction and thereby is a mechanism for disease, including causing chronic vasculopathy in sickle cell disease and other hemolytic conditions.

*Demonstrate how patients with hemolytic anemia, such as sickle cell disease, can develop pulmonary hypertension.

*Review a pathological role for intravascular hemolysis and cell-free hemoglobin in transfusion medicine, surgery, malaria and other human diseases.
