Prior studies have shown variability in the treatment of EoE (Hirano Gastroenterology 2020, Spergel JPGN 2011, Lipka J Clin Gastro 2018); There is a large unmet need in the management of EoE and eosinophilic gastroenteritis due to the limitations of currently used treatments and the absence of FDA approved medications (Rank Gastroenterology 2020). Objectives: Appreciate concerns with symptom-based management of eosinophilic esophagitis; Review advances in the treatment of eosinophilic esophagitis; Identify novel approaches to the management of eosinophilic gastroenteritis.
