## **Electronic Death Certificates**

Beginning on February 28, the Connecticut Department of Public Health will require its electronic system to certify deaths. The CT DPH website has enabled their self-enrollment link. Currently over 6500 providers have had credentials uploaded. Temporary credentials have been sent out to user's email.

- YNHHS will transition to electronic certification of all deaths on February 28, 2022.
- Providers should look for their temporary credentials in their work email. Log into their account as soon as able to change their temporary password. If the temporary password is not changed, the account may be locked and will require a call to the DPH help desk.
- If a provider has not received temporary credentials, they should use the selfenrollment function at <u>https://ct-vitals.ct.gov/production/Logon.aspx</u>
- All death certifications after midnight on 2/27 will need to be done via this electronic system

### **Teaching Physician Guidelines**

It is critical that when an Attending Physician acts as a Teaching Physician with a Fellow or Resident, they must follow the documentation guidelines issued by the Centers for Medicare and Medicaid Services (CMS) for the Attending Physician to bill for the clinical services rendered.

### **Evaluation and Management Services**

The Fellow/Resident may document their performance of the Evaluation and Management service, but the Teaching Physician must also see and evaluate the patient and their documentation (referred to as the "Teaching Physician Attestation" or TPA) must include a signed addendum to the Fellow/Resident note – personalized to that patient – that indicates:

• You saw the patient

- You evaluated the patient
- What your participation was in the treatment plan/management for that patient
- Generic attestations alone are not acceptable
- The guidelines do NOT allow a Fellow/Resident to document the Teaching Physician's presence and participation in an Evaluation and Management service

## **Surgical Services**

When the surgeon performs a single major procedure (case), the op report may be dictated by either the surgeon or the resident/fellow on his/her behalf

- If the op report is dictated by the resident, the surgeon must personally document their presence during the critical or key portion(s) of the procedure in the form of an attestation in the documentation, or via a simple declarative statement in the body of the report the resident cannot document the presence of the surgeon
- An op report dictated or authored by the attending surgeon does not adequately support that the attending was present for the entire operative/high risk procedure or the critical/key portions when a resident/fellow is included in the header of the operative report
- The TP/attending surgeon must sign the operative report
- When the surgeon is acting alone in the case and dictates the op report (no one else is indicated in the header of the operative report or referenced in the body of the report), no attestation is needed
