## Smilow Update: June 8, 2020

#### **Ambulatory Moves**

Thank you to our Ambulatory Transformation team, and the leadership of Maureen Major Campos, RN, and Anne Chiang, MD, for their tremendous work transitioning many of our clinical teams over the weekend to ensure our clinics were in place and ready for our patients this morning, and to all of the members of the Clinical Programs impacted by the moves. Thanks to the stellar organization and packing by each of the teams that moved, everything was in place by 7:30pm on Friday. A special shout out to our Smilow Operations, Facilities, IT, and Epic teams for their support, and to the GynOnc team for their extra organized packing skills! We appreciate everyone's dedication to our patients, dependability, and flexibility.

The following Clinical Programs are impacted by the moves this weekend:

- Breast Cancer, Prostate and Urologic Cancers, Endocrine Cancers, and Pain & Palliative Care are now located on NP 4.
- GI Surgery, Head and Neck Medical Oncology, Melanoma, Neurosurgery, GynOnc, Apheresis, and Ophthalmic Oncology are on NP 8.
- Due to the limited amount of space, please be mindful of social distancing while in our clinic areas.
- Two patients will be scheduled per hour, per clinician between the hours of 7:30am-5pm; patients can also be scheduled through the noon hour. No double booking of appointments.
- Clinicians are encouraged to continue with 50% of their practice through Telehealth.
- It is strongly encouraged that patients have labs scheduled the day before an appointment to encourage timely appointments.
- In clinic, staff will be limited.
- Patients have been called, and will receive mail communication as well.

#### Asymptomatic Employee Testing

The YNHHS is rapidly escalating the volume of voluntary COVID testing for asymptomatic staff. Of over 1,800 staff have been tested since the pilot began on May 15, only five, .27%, have tested positive. These initial results indicate a very low risk of asymptomatic transmission in our workplace.

- Testing is one more step in safeguarding the health and safety of staff and patients, and supplements use of PPE, adherence to social distancing, and hand-hygiene expectations.
- The pilot reflects YNHHS's support for the governor's commitment to rapidly expand testing for healthcare workers and others in our state.
- Testing is available by appointment only for employees.
