The SARS-COV-2 Pandemic resulting in COVID19 illness is a new disease and our understanding of the biology of the disease and the appropriate management is rapidly evolving such that data and management used even 3 – 6 months ago has changed. Use of Bipap, High Flow Nasal Cannulas, and ECMO have all evolved rapidly institutionally and have very specific indications. Additionally, the morbidity and mortality outcomes have continued to evolve along with pharmaceutical interventions.
