NEEDS ASSESSMENT

Thyroid disease is very common affecting 9-15% of US adults and often with characteristic associated cardiovascular symptoms. Far less common today are presentations of undiagnosed or untreated thyroid disease leading to extreme thyroid dysfunction, which can have highly variable presentations and dramatic cardiovascular implications. Early recognition of severe thyroid dysfunction and understanding of its mechanistic role in cardiovascular complications is central to initiating proper treatment and improving outcomes.

LEARNING OBJECTIVES

At the conclusion of this activity, participants will be able to:

1. Identify common cardiovascular signs and symptoms characteristic of hypothyroidism and hyperthyroidism.
2. Identify and understand the most appropriate initial thyroid function tests for confirming a suspected diagnosis.
3. Develop an appreciation of cardiac complications of severe thyroid dysfunction and specific considerations in treatment.

4. Further discuss the multidisciplinary management of patients with co-existing cardiac and thyroid disorders and implications on the treatment of their cardiovascular disease.
