#### Abraxane Update

Abraxane has been on a nationwide shortage since the end of September. Smilow Cancer Hospital has developed strategies and guidelines to manage the limited supplies over the last two months. Despite the continued shortage, Smilow Cancer Hospital has been able to secure a small quantity of drug that will allow us to expand access to patients with no other treatment options.

Effectively immediately:

- 1. Current patients with curative disease will continue to complete their treatment course.
- 2. Patients with non-curative disease who were already switched to alternative therapy (i.e., taxol, oxaliplatin or others) should continue on their current treatment.
- 3. Current patients with non-curative disease with Abraxane held in the current treatment plan can resume Abraxane
- 4. New treatment initiation can be considered with following criteria:
  - Patients have had prior severe tanxane HSRs (bronchospasms, hypotension or hypoxia requiring treatment) and alternative is not an option. For mild to moderate HSRs, re-challenge with addition premedications and slower rate titration should be considered.
  - Pancreatic cancer treatment in the second line setting (i.e., patients progress on FOLFIRINOX and clinical trial is not an option).
  - Requests for a new start outside of the above criteria requires an approval from **Kerin Adelson, MD**, Chief Quality Officer.
  - We will continue to reevaluate our supply and update these recommendations as necessary.

# Faculty Members needed for Research Oversight Committees

The Protocol Review Committee (PRC) and Data and Safety Monitoring Committee (DSMC) are looking for faculty members to serve on these important research oversight committees which serve a vital function for Yale Cancer Center.



The PRC assures the scientific quality of the oncology clinical research performed at Yale. The mission of the PRC is to: 1) review interventional protocols for scientific merit; 2) identify conflicts between studies that compete for the same patient population or are not consistent with the YCC programs and goals; and 3) review and vote on study closure recommendations

for underperforming studies. Meetings occur twice monthly for approximately one hour per meeting.

The DSMC monitors the safety of all cancer-related clinical research. The DSMC provides safety and compliance oversight of clinical trials through review of serious adverse events, protocol and subject deviations, internal and external audit reports, protocol-specific data and safety monitoring reports and multi-center activity reports. Meetings occur once monthly for approximately two hours per meeting.

PRC and DSMC members are appointed for three year terms with reappointment possible following successful completion of a term. Please reach out to **Stephanie Brogan** if you are interested in becoming a member or would like more information regarding these opportunities.
