NEEDS ASSESSMENT

In the context of the COVID-19 pandemic and ongoing racial violence and injustice, renewed and pressing considerations arise regarding the duty of physicians to uphold the ethical principles of justice and equity and increase their structural competence in addition to cultural competence. Physicians must be able to explain the concepts of diversity, inclusion and equity, racism and antiracism, develop critical analysis of how these concepts work in medical education, training, research and patient care. Despite the demonstrated benefits of a diverse physician workforce, representation of minority racial/ethnic groups remains disproportionately low. The reasons for low representation of URM are complex and often rooted in the institutionalized barriers. Urologists require education on these issues to provide structurally competent education and patient care.
