(Obstet Gynecol 2014 Nov; 124(5):941-946; Obstet Gynecol 2015 June; 125(6):1481-1485). Dr. Chen focuses on identifying and evaluating apps for Ob-Gyns to use in clinical practice. Participants will leave grand rounds with an understanding and confidence on how to use recommended apps.
