# COVID-19 Update: April 22, 2020

## **PPE Update**

The CDC and State of Connecticut now recommend everyone use cloth face masks in public. YNHHS continues to resource PPE to ensure the safety of all of our clinicians and staff. We are especially grateful to Dr. Mehra Golshan who recently secured and donated 40,000 surgical masks to YNHHS to help support our needs. We look forward to welcoming Dr. Golshan to campus in his new role as Deputy CMO for Surgical Services at Smilow Cancer Hospital in June.

- All clinicians and staff will wear face masks throughout our healthcare facilities.
- Ambulatory patients and visitors will be instructed to wear face masks in patient care facilities. To the extent possible, patients and visitors are encouraged to bring and wear their own face masks. If they arrive without one, a face mask will be provided.
- Because of variations in supply, the YNHHS inventory of PPE is now more diverse than usual. Different face masks, protective clothing, N95 respirators, and equivalents may be delivered to your care delivery areas.
- In order to help providers determine which protective equipment should be used, please refer to the <u>"Order of Use"</u> description for face masks, respirators, and protective clothing.

#### **COVID-related Research**

Yale Cancer Center members, **Eric Meffre, PhD**, and **Aaron Ring, MD, PhD**, are collaborating to study the development of immune responses targeting SARS-CoV-2.

- Their project hypothesis is that anti-SARS-CoV-2 antibody responses generate neutralizing protective antibodies in most patients, but that S1 spike protein-reactive antibodies may cross-react with self-antigens expressed on lung epithelial cells in patients severely affected by the virus. This is based on previously documented SARS-CoV research.
- Their current research will analyze the two mechanisms of immune response to SARS-CoV-2: protective antiviral immunity versus harmful immunopathology.

• The overall goal of their project is to identify protective antibodies, and to subsequently develop potential therapeutic agents against the virus.
