### NEEDS ASSESSMENT

-A recent survey by Ahn et al. for gastroenterologists and hepatologists has observed that physicians had a knowledge gap related to the utilization of antiviral therapies to prevent mother to child transmission of hepatitis B. (Ahn J, et al. Gastroenterol Hepatology. 2010;6:570-578).  
-Physicians often have knowledge and performance gaps in using available data to counsel patients about safety and efficacy of antiviral therapy during pregnancy, particularly for patients with high risk for mother to child transmission of hepatitis B.  
-There are new association guidelines (AASLD) on the management of pregnancy with hepatitis B
