

Congratulations to the Smilow teams for achieving 375 days without a Serious Safety Event. The safety of our patients and our employees is our biggest priority. To achieve the highest level of safety and the least amount of harm to our patients, visitors, and staff, we are grateful to all our Smilow physicians, providers, nurses, and staff who continue to make a commitment to building a culture of safety.

A serious safety event is an event that reaches the patient resulting in harm and ranges from moderate to severe patient harm or death. Our safety events are classified using the Healthcare Performance Improvement (HPI) model.



The Smilow Quality and Safety team would like to thank all the Smilow teams for their commitment to safety. This past year continues to be one with many challenges and competing priorities, but we continue to put our patients first. Congratulations on this huge accomplishment!

Elizabeth Prsic, MD, Appointed NP12 Firm Chief

Ambulatory Ethics Consults

The Ethics Committee at YNHH is offering consults for inpatient care but is also available for selected outpatient consults. They offer guidance concerning:

- Uncertainty as to who should make health care decisions for patients too sick to speak for themselves
- Religious or cultural beliefs that conflict with medical treatment
- Disagreements over starting, continuing, or ending medical treatments
- End of life issues, such as the removal of a feeding tube
- Decisions about organ donation
- Questions about ethical policies or guidelines
- Concerns about advance directives
- The rights of a patient

Providers seeking ethics consults for ambulatory visits should first contact the ethics committee for the hospital with which they are affiliated. Extended Care Center Coverage

The Smilow Hospitalist covering the ECC will be available 7 am to 11 pm via the Mobile Heartbeat role Smilow Cancer Hospital ECC ON CALL HOSPITALIST.

Greenwich Hospital NAPBC Accreditation

We are happy to share that Greenwich Hospital has received accredited status from both the National Accreditation Program for Breast Centers (NAPBC) and the Commission on Cancer (CoC) after completing a joint survey in June.

To achieve voluntary NAPBC accreditation, a breast center must demonstrate compliance with the NAPBC standards that address a center's leadership, clinical services, research, community outreach, professional education, and quality improvement for patients. Similarly, CoC accreditation is granted to a cancer program that meets 34 CoC quality care standards, participates in an evaluation every three years through a survey process, and maintains levels of excellence in the delivery of comprehensive patient-centered care. Today we recognize the incredible contributions of Sandra Cassell-Corbin, APRN, Annie Jha, PA, and Mark Tabaka, **PA**, as well as the other APP and Oncology Fellow providers, who provide excellent care to our patients daily in the Smilow Extended Care Clinic. The Oncology Extended Care Clinic (ECC) has been open since April 2017. It has the capacity for 6 patients and the unit is dedicated to serving our patients in need of urgent care and to avoid the ED. Sandy, Annie, Mark, and others provide APP staffing for the clinic, in collaboration with a team of nurses and ACAs, and physician rotation from the Hospitalist service. Sandy, Annie, and Mark bring extensive oncology/urgent care expertise to their roles in the ECC, which benefits



the diverse patient population they care for. The ECC has been a wonderful service for our patients which has been evidenced by Press Ganey satisfaction scores and that at least 65% of patients seen in the ECC are discharged to home.
