Arryn Guy

Investigator, Brown University School of Public Health

Dr. Arryn A. Guy (she/they) is an Investigator in the Department of Behavioral and Social Sciences at the Brown University School of Public Health. She received her PhD in clinical psychology from the Illinois Institute of Technology in Chicago, IL, and was a clinical psychology resident at the Edward Hines Jr VA. Dr. Guy completed an NIMH-funded T32 fellowship in Biobehavioral HIV research at Brown University in the Department of Psychiatry and Human Behavior, while cross-training with the Alcohol Research Center on HIV (ARCH) and Center for Alcohol and Addiction Studies (CAAS) in the School of Public Health. Dr. Guy's work focuses on community-based participatory research with Queer and Trans People of Color to develop and implement evidence-based behavioral health interventions. Their work aims to heal negative psychological sequelae resulting from stigma, reduce HIV-related comorbidities, and increase HIV viral suppression - with the ultimate goal of reducing HIV health inequities. Dr. Guy is the PI of a NIDA-funded K99/R00 to adapt and test an acceptance and commitment therapy (ACT)-based, gender-affirming stigma intervention that targets substance misuse and HIV risk among trans women. Their work spans across the Alcohol Research Center on HIV (ARCH), the Center for Alcohol and Addiction Studies (CAAS), and the Mindfulness Center at Brown.

Paul Goulet

Chair, Providence Boston CFAR Community Engaged Research Council

With more than 36 years of experience working in health policy, and consumer advocacy, Paul Goulet is an independent consultant specializing in Community Engaged Research to provide maximum impact with patient retention in health care, specifically for patients living with HIV/AIDS who are homeless, incarcerated, participate in active drug use, mental health issues, trauma or who have not been retained in their health care. Paul has previously served as Program Manager for the Special Linkage and Retention Team (ARCH Team) at the Shapiro Clinic, Center for Infectious Disease, Boston Medical Center; was Director of the Massachusetts Department of Public Health's Consumer Office and Director of Community Engagement for eleven years, and was the former facilitator of the Massachusetts Statewide Consumer Advisory Board for over fifteen years. Paul is a board member of the National Quality Center, Consumer Advisory Council (NYC), and the Chair of the Providence Boston CFAR (Center for AIDS Research) - CCERC (Community Engaged Research Council).
