Needs assessment: Chronic constipation is a prevalent and burdensome condition that is multifactorial (slow transit constipation, defecatory disorders, IBS-C, medication-induced, etc) and associated with treatment failure and patient dissatisfaction. In the past 10 years new therapeutics have been introduced and new evidence has emerged for non-pharmacologic therapies including behavioral interventions and pelvic floor physical therapy in the case of dyssynergic defecation. In addition, recognition of the importance of the biopsychosocial model of disease has provided a framework for providers to recognize the importance of quality of life and patient reported outcomes. Objectives: Recognize symptoms and etiologies of chronic constipation; Understand techniques that behavioral psychologists and pelvic floor physical therapists may use respectively to treat underlying issues associated with constipation; Understand the recommendations for over the counter and prescription therapy for chronic constipation.
