Smilow Town Hall

Testing and Masking Updates

Admission COVID-19 testing ended on Monday, May 1, 2023. This includes all asymptomatic patients admitted from other facilities, admissions for surgery/procedure, ED, and direct admits.

- Admission testing will continue for inpatient Behavioral Health Units.
 - Admission testing will continue for patients with symptoms concerning for COVID-19.
- Admission testing will continue for patients who report close sustained contact with a person with an active COVID-19 infection and who have not had COVID-19 in the past 90 days.

The requirement for mask use in public areas (i.e., lobbies, waiting rooms, cafeteria, hallways, nursing stations) will end on Thursday, May 11, 2023. Inpatient areas:

- Staff will continue to mask in all patient rooms, diagnostic/procedural rooms, and when providing direct individual care in close contact with patients.
- Patient and accompanying family/visitors are encouraged but not required to mask
- Ambulatory (Medical offices, draw stations, diagnostic imaging, etc.)

All areas:

- Staff will continue to adhere to all policies related to transmission-based precautions (i.e., isolation).
- Staff and visitors with signs or symptoms of COVID-19 or other potentially communicable disease should remain home.

Heparin Flushing

A multidisciplinary group within Smilow has rolled out a new initiative to eliminate heparin flushing from all central lines. This is an important practice change to keep YNHHS aligned with national best practice standards. On Tuesday, May 2, 2023, all YNHHS nursing staff began to use the pulsatile and push-pause technique for CVAD flushing with NS. Heparin flushes, both 10 units/mL and 100 units/mL, have been removed from order sets, treatment plans, therapy plans, and patient care areas. Central line order sets and therapy/treatment plans should be consolidated to one order set and one therapy plan for the system.

Cisplatin Supply

Cisplatin supply remains on allocation; however, we have obtained sufficient quantity for our system for now. Currrently, Cisplatin can be used for all treatment indications. We will continue to reevaluate our supply and provide updates as necessary.

Preferred Specialty Pharmacy for Specialty Medications

Effective Tuesday, May 9, 2023, Preferred Specialty Pharmacy will go live in all Smilow Outpatient Departments, including adult and pediatrics and two inpatient pediatric oncology units: YNH SP 73 BMT and YNH WP 7 Pedi Hem Onc and Epilepsy.

Preferred Specialty Pharmacy aims to improve the clinical continuity of care for our patients. When a clinician orders a specialty medication, the order will be sent to Outpatient Pharmacy Services at YNHHS (OPS), the preferred health system integrated specialty pharmacy. Once the benefits investigation is completed the OPS staff will then reach out to the patient to provide an introduction of services, providing the patient a choice of specialty pharmacies. A prior authorization (if required) will be completed on behalf of the clinic. If the patient prefers to continue with OPS then the patient will receive education and support from our specialty pharmacy team as outlined in our disease specific patient management programs. A liaison will schedule deliveries/pickups and refills. In addition, pharmacy staff will assess and coordinate need for financial assistance, if applicable.
