### **Inpatient Care Returns**

After 426 days of COVID ICU Status, we are proud to announce that NP15 has transitioned back to Smilow Cancer Hospital inpatient cancer care and our surgical oncology team moved back from NP14. In addition, Gynecologic Oncology will move from SLA5 on the Saint Raphael Campus today, June 7th to NP14.

### **Mobile Heartbeat**

Mobile Heartbeat is the only HIPAA-approved clinical texting device for unified clinical communications at Smilow Cancer Hospital and throughout Yale New Haven Health, including at many of our Care Center locations. We ask that all providers add Mobile Heartbeat to their phones for streamlined, easy communication regarding patient care both on campus and off. Mobile Heartbeat includes:

- A System-wide directory of hospital employees and contact information by role, location, and status.
- Ability to create custom status messages and notify colleagues of shift covering and availability.
- Ability to view a patient's care team, along with their availability in real-time.
- Secure, HIPAA-compliant texting, 1-1 and group texting.
- Patient photography to upload to a patient's EMR.

### **Inpatient Visitation Update**


Beginning last Tuesday, June 1, YNHH made one change to the inpatient visitation policy to expand the hours of visitation. 1 visitor is allowed for adult COVID negative inpatients on their 1st day of hospitalization from 10am-8pm daily. One visitor per day, no switching during the day, although patients can have a different visitor each day. Patients on COVID

units, regardless of COVID status are not eligible for visitation. Cafeteria access is no longer restricted.
