Smilow Update: July 10, 2020

Smilow Cancer Hospital Volumes

Our visit volumes continue to rebound, with only a 3% decrease in total visit volume from February (22,677) to June (21,925). Smilow providers are consistently completing over 8,000 video and phone visits per month.

Blue and White Inpatient and Consult Service

Beginning July 18th, medical oncology blue and white inpatient service and consult attendings will transition start days from Monday to the previous Saturday. The goals of changing attending start day to Saturday are:

- To improve patient care by moving beginning of service time to days with fewer admissions, meetings, calls, and no clinics. We hope this will enable teams to start Monday with a better understanding of and care plan for both inpatients and consults.
- To minimize multiple team members changing during the week (interns transition Tuesdays, residents Wednesdays and fellows on Mondays)
- To allow inpatient providers to have a weekend off at the end of service time to recover prior to another work week.

Anthem's Oncology Medical Home Model

We are pleased to announce that Smilow Cancer Hospital is participating in Anthem's Oncology Medical Home (OMH) Model. Anthem's OMH is a new value-based payment program that focuses on delivering high quality, patient-centered care through enhanced care coordination, shared decision-making, reducing low value acute care utilization and maintaining adherence to evidence-based clinical pathways.

Eligibility

 Patients between the ages of 18-75 who are receiving cancer treatment with a drug therapy and are covered under one of Anthem's commercial plans are eligible for this program.

Incentives

- Smilow will receive a monthly care coordination population payment for eligible patients (\$165 PMPM)
- Smilow is eligible to receive a performance-based payment if we meet minimum performance targets on quality measures like avoidable ED and hospitalizations and clinical pathways adherence

Building on our infrastructure and experience from the CMS Oncology Care model, our participation in Anthem's new program extends our efforts in reducing acute care utilization and providing high quality care for Smilow patients. It also affirms our commitment to partnering with payers to do what is right for our patients. Anthem will provide us with additional revenue to deliver on this mission. Moreover, we will gain essential expertise in value-oriented care models so that we can lead the field in improving cancer outcomes. Please contact Nara Sinanis for more information.
