Schwartz Rounds

Yesterday's Schwartz Rounds provided us a profoundly thought-provoking forum to have open discussions on diversity and inclusion within our Smilow Cancer Hospital and Yale Cancer Center community. We were honored to have so many members of our faculty and staff join us for an open, honest, and vulnerable conversation. Thank you to Drs. Katherine Tucker and Darin Latimore for their leadership in this arena and for sharing their own personal experiences to open dialogue among our team. Also, thank you to Drs. Tara Sanft and Jennifer Kapo and Anna Raso for their work in creating virtual Schwartz Rounds over the past several months. We especially appreciate each person who shared their feelings, personal thoughts, and concerns. We know we have many areas to improve on, and we are fully committed to working with all of you to ensure real change. Clinical Research

Under the leadership of Roy Decker, MD, PhD and Joyce Tull, RN, our clinical research initiatives are continuing to expand and trials are available for new accruals for our patients.

- Our Clinical Trials Office (CTO) has successfully transitioned from Phase O to Phase I with limited trials open for accrual, continued remote CTO support of clinicians, and limited Clinical Research Support Laboratory (CRSL) access in New Haven, Trumbull, and North Haven.
- The CTO staff continues to remotely monitor and care for 160+ research participants weekly. Since reopening enrollment two weeks ago, they have consented 35 patients and 11 have been enrolled.
- Planning is underway for Phase II to begin on July 11 in compliance with the Provost's direction. We hope we will be able to expand accruals, expand CRSL access, and have more regular CTO personnel on campus. Updates will follow!

Cancer Survivorship

Our Cancer Survivorship teams launched a Virtual Cancer Survivorship Celebration in honor of Cancer Survivors Day on June 7. Asymptomatic Employee Testing

The YNHHS is rapidly escalating the volume of voluntary COVID testing for asymptomatic faculty and staff. Thus far, only 14% of healthcare workers have sought out testing, although the rates of positive infection remain extremely low at .24%. All Smilow Cancer Hospital providers and staff are encouraged to schedule testing.

- Testing is one more step in safeguarding the health and safety of staff and patients, and supplements use of PPE, adherence to social distancing, and hand-hygiene expectations.
- Please schedule a test, which is available by appointment only for faculty and staff.

Saint Raphael Campus and NP11 for Oncology have been COVID tested in advance, including assisting with the facilitation of the testing process, checking that orders are entered correctly, and verifying that patients are scheduled appropriately and being tested at the proper location.

Most recently, Eileen has been working with the Supportive Care Unit, which offers full multidisciplinary palliative care support for patients and their families, to identify patients throughout the entire hospital system who are pursuing comfort measures. Eileen is a former hospice nurse, and a cancer caregiver herself. Eileen's experience and passion for cancer care make her a true Smilow Star!
