NEEDS ASSESSMENT

Steroids modulate innate and acquired immunity leading to increased risk, in a dose-dependent manner, of bacterial, viral, and fungal infections. Other factors can amplify this risk, including concomitant immunosuppressive therapies, lymphopenia, and age. Despite this risk, steroids' quick onset of action make their use indispensable when first controlling inflammation in multiple diseases. Dr. Meindertsma will guide us through steroid physiology in infection, will explore existing clinical data on steroids in infections, and will consider clinical scenarios of giving steroids to patients with infections.
