Project background: In 2023, the Global Fund developed and implemented health facility assessments (HFA) as part of monitoring and oversight of investments made under the COVID-19 response mechanism (C19RM). The overall model and methodology of the HFA is based on WHO harmonized health facility assessment guidelines and tools.

Description of proposed work: Analysis of hospital/clinic level health systems capacity and readiness data across select technical domains, including country-specific & overall.

PC services include long-term and remote case management, health and medical interventions, mental health interventions, and social adjustment services, as well as addressing the nuanced needs of separated children in particularly vulnerable situations.

Description of proposed work: With oversight from the PC Child Protection Program Officer, Fellows will play a central role in assessing and supporting the needs of separated children referred to or served through IRC's Preferred Communities Programs. They will assist with the development of assessment structure, recruiting participants, and providing feedback and engagement to center minor needs throughout PC programming.

Organization description: The International Rescue Committee (IRC) helps people affected by humanitarian crises to survive, recover and rebuild their lives. The Preferred Communities program serves the most vulnerable refugees, asylees, and other populations across 27 of IRC's U.S.-based locations. We provide strengths-based, client-centered case management services focused on addressing clients' medical needs, disabilities, mental health and behavioral health needs.

Project background: This project will focus on providing virtual supplemental case management to vulnerable newcomers for whom in-person services are not an option. The project will focus on providing virtual medical, mental health, and behavioral health-related case management for newcomers who are considered especially vulnerable. This project will act as a support to guide clients and their support networks towards necessary resources that address their needs to reach a level of self-sufficiency.

Description of proposed work: Fellows will take on the role of "navigators" for refugees, Cuban/Haitian entrants, Ukrainian Humanitarian Parolees, and other immigrant populations as they learn the U.S. medical system, apply for medical insurance, and access medical and mental health care. With support from their supervisor, fellows will assess the client's needs, create a service plan in collaboration with the client that identifies the client's goals, barriers to the goals, and strengths that will help them reach their goals. Fellows will then support the clients as they implement their service plan to reach their goals, communicating with the client on a weekly, sometimes daily basis depending on the client's need.

Key Responsibilities

- Complete an assessment of the client's needs
- Complete a service plan that identifies the client's goals, barriers, and strengths
- Communicate with the client regularly in order to support the client to reach their identified goals
- Map community assets and help make referrals to community partners where client resides

- Advocate on the client's behalf when clients run into barriers to accomplishing goals due to systemic issues or errors
- Communicate regularly with the fellow's direct supervisor to ensure critical incidents are escalated and reported as needed, or complex matters are adequately resolved

Reporting or Deliverable Requirements: A two-page report on trends observed across clients served, including the most common needs of clients, any observed gaps in meeting these needs, and recommendations for improvement of programming.

Description of proposed work: Support the Program Officer for Training, ICM, in knowledge management, training content development, and data entry. Assist in gathering data for the upcoming staff mentorship pilot aimed at professional growth. Contribute to training resources focused on social and emotional wellness for direct service providers, incorporating social work ethics and principles, resulting in added capacity to support local sites in delivering enhanced training and professional development resources.

Project background: The climate crisis is a health and development crisis. Climate change is disrupting essential services, straining health and food systems, and increasing risks from both infectious and non-communicable diseases, for example.

The law represents a powerful tool for advancing health and equity in the context of a fast-changing climate, including by addressing the underlying determinants of health. Space to protect health through climate litigation is growing. In 2022, the UN General Assembly recognized the right to a clean, healthy and sustainable environment. As part of the Human Rights 75 Initiative, UNDP has pledged to support 100 countries in operationalizing this right.

Description of proposed work: Building on UNDP's long-standing experience and capacities at the nexus of health, rights and the law, including for example the landmark Global Commission on HIV and the Law, the fellow will be responsible for researching the area of climate, health and the law. That includes examining the state of this field, how it can best support country action, and existing/needed partnerships, platforms and activities to advance climate and health law.

Organization description: The United Nations Development Programme (UNDP) is the knowledge frontier organization for sustainable development in the UN Development System and serves as the integrator for collective action to realize the Sustainable Development Goals (SDGs). UNDP's policy work carried out at HQ, Regional Hubs and Country Office levels, forms a contiguous spectrum of deep local knowledge to cutting-edge global perspectives and advocacy. In this context, UNDP invests in the Global Policy Network (GPN), a network of field-based and global technical expertise across a wide range of knowledge domains and in support of the signature solutions and organizational capabilities envisioned in the Strategic Plan.

UNDP delivers support to countries in three areas of HIV and health: reducing the inequalities that drive disease, promoting effective and inclusive governance for health and building resilient and sustainable systems for health.

Project background: Since 2015, UNDP has worked with WHO, the UN Interagency Task Force on NCDs, the Secretariat of the WHO Framework Convention on Tobacco Control, and other partners to support countries in conducting national health investment cases. That includes cases on non-communicable diseases, tobacco control, air pollution, primary health care and other issues. The cases analyze the costs of illness – to the health sector and economy writ large – and the return on investment from scaled up action. The cases include an institutional and context analysis that looks at context-specific barriers and opportunities to implement recommended interventions, as a supplement to the economic analysis.

There has been initial inquiry into the findings, impacts and value of investment cases, for example a 2024 review in <u>BMJ Global Health</u> of just 13 national NCD investment cases found, as reported by governments, 47 policy impacts from the cases. There were across three main areas – governance, financing, and health service access and delivery – and broader health and development benefits, for example, progress towards universal health coverage, were noted. However, there is a need to more fully capture the impacts and experiences around national health investment cases, including in the context of an evolving global health financing landscape and the need to accelerate progress on the health-related Sustainable Development Goals.

Description of proposed work: The fellow will be responsible for data, analytics, communication and inputs to program design around UNDP-supported investment cases for health. That includes, for example:

- Communicating the return on investment in health prevention and response and centering costed and prioritized actions within resource mobilization targets as well as budget allocations.
- Demonstrating the value and uses of investment cases in catalyzing longer-term resources for countries to sustainably deliver multisectoral action for health.
- Articulating demands and needs from countries in follow on investment case support to ensure fuller implementation.
- Identifying needs around deeper-dive investment case analytics and relevance to policies and programs for health, for example with respect to vulnerable populations and inequalities.

Project background: Climate change is devastating lives, undermining progress made in improving access to sanitation, and hampering achieving universal access to climate-resilient and safely managed sanitation. Many of the unserved population with safely managed sanitation live in in water-stressed or flood-prone areas and these people are further being left behind due to impact of climate change. Additionally, unsafely managed sanitation is a significant contributor of greenhouse gas (GHG) emissions. Despite the impacts of climate on sanitation and sanitation's contributions to climate change, sanitation has not been a part of global climate discussions and receives virtually no funding from global climate funds.

In response to this situation, in 2022 UNICEF, WHO, the World Bank and 15 other leading climate organizations issued a *Call to Action* at COP27, with an accompanying <u>technical brief</u>. The Call to Action made specific requests to governments, development partners, donors, academia, private sector, and activists to support the CRS agenda. In addition, UNICEF is coleading the Climate Resilient Sanitation Coalition¹ which was formed in 2023 for increase advocacy on mainstreaming of climate resilient sanitation in global climate discussion, national policies, plans and budget. The Coalition is working on medium and long-term plans to strengthen evidence generation, research, cross-learning as part of the overall efforts of mainstreaming sanitation in global and national climate agenda. The Coalition has just supported Green Climate Fund (GCF) to develop Practical Guidelines for Designing Climate Resilient Sanitation Projects which was launched at COP29 as part of the efforts of mobilizing climate finance for CRS.

Description of proposed work: The main purpose of this internship is to support the UNICEF Sanitation and Hygiene Team in capturing, documenting and disseminating events and

initiatives from the implementation of Climate Resilient Sanitation Coalition workplan and the roll out of the GCF Guidelines on Climate Resilient Sanitation.

Project background: Climate change continues increasing the frequency and intensity of extreme weather events worldwide, resulting in climate-related hazards such as hurricanes, heatwaves, droughts, extreme rainfall, floods and severe cyclones. These events make water, sanitation and hygiene (WASH) infrastructure vulnerable to damage, impacting access to and functionality of WASH infrastructure and services in schools.

When WASH services are disrupted, children become vulnerable to WASH-related diseases and infections, which increases their vulnerability to climate change impacts and environmental hazards, which affects their educational and health outcomes.

Governments and partners will need to invest in climate-resilient WASH to achieve increases in basic WASH services in schools. This investment includes building WASH infrastructure that can withstand the impact of extreme climate-related events, promote and support renewable energy sources such as solar, increase investments to WASH infrastructure, and build government capacity to provide leadership in the provision of equitable and sustainable WASH in schools (WinS).

UNICEF guidance includes the Strategic Framework for WASH climate resilience, developed jointly with the Global Water Partnership (GWP), with accompanying resources, and the UNICEF Guidance Note on the shift to climate-resilient WASH programming. UNICEF provides technical support to governments around the world on climate-resilient WASH programming in communities and schools, leading to increased access to climate-resilient WASH services.

Based on these resources, UNICEF is in the process of finalizing a Climate Resilient Framework for WASH in Schools. Simultaneously, WinS sector partners are developing guidance, tools, standards, etc., for Climate Resilient WASH in Schools (CR WinS). As one of the leading development organizations in the WinS sector and the CR WASH sector, UNICEF aims to ensure

coordination and alignment for development of new or revised guidance, tools and standards for CR WinS.

Simultaneously, UNICEF coordinates and implements School Health and Nutrition Programs, which include a WASH component. School health and nutrition aims to protect and promote the health, nutrition, well-being and development of school-age children and adolescents and the wider school community through coordinated and comprehensive strategies, activities and services that are integrated and sustained within the education system.

School health and nutrition policies and programs are by nature inter-sectoral; they require effective collaboration between the education, health and WASH sectors, but also food and agriculture, local development, finance, social welfare and other relevant sectors.

At the global level, UNICEF coordinates School Health and Nutrition initiatives with other UN agencies (WHO, UNESCO, WFP) and within UNICEF with other sectors (education, health, nutrition, WASH). UNICEF is in the process of developing a UNICEF Programme Guidance for School Health, Nutrition and WASH programming for UNICEF Country Offices.

Description of proposed work: The intern will support UNICEF to map stakeholders active in the CR WinS and identify opportunities where UNICEF can take leadership in the sector and can collaborate with others. The intern will also support review and analysis of existing or draft CR WinS guidance, tools, standards. Lastly the intern will support the documentation of lessons learned and case studies on CR WinS and School Health Nutrition and WASH programs.

Project background: During the COVID-19 pandemic, hand hygiene was one the key public health measures to limit transmission. However, questions around when and how to wash hands were raised. Under the mandate to provide evidence-informed guidance to address uncertainties in public health policy and practice, WHO and UNICEF decided in 2021 to provide new guidance on hand hygiene to address these areas of discordance and gaps in existing global guidance.

In mid-2025, UNICEF and WHO will be publishing the new Normative Guidance on Hand Hygiene in Communities, in response to expressed demand from countries and partners. It will consist of eight key evidence-based recommendations which will provide important public health guidance to governments and partners, in particular contributing to ongoing efforts by WHO, UNICEF and others to strengthen the global architecture for health emergency prevention, preparedness, response and resilience.

For UNICEF, the next step will be for our Country Offices to support governments in implementing this guidance. Supplemental resources will be needed to make the guidance applicable to different settings and discuss strategies for changing behaviors.

Description of proposed work: The fellow will support UNICEF to develop resources to complement the Normative Guidance for Hand Hygiene in Communities, including fact sheets for specific settings (e.g., workplaces, schools, etc.) as well as behavior change.

Organization description: As the global climate crisis escalates, its devastating impacts on human health and well-being will also accelerate. No one anywhere around the globe is beyond its reach, though millions of people – notably, women, children, the elderly, ethnic minorities, people with pre-existing health conditions, and those living in poverty – are among the most vulnerable.

Changing climate conditions are increasing heat-related illnesses and deaths; changing the patterns of infectious disease transmission, making deadly disease outbreaks and pandemics more likely; worsening maternal and child health outcomes; and intensifying health impacts from extreme weather events such as floods, droughts, wildfires, and windstorms. Climate change exerts significant strains on health systems, simultaneously increasing demand for health services whilst also impairing the system's ability to respond. The climate crisis is also rapidly deteriorating access to basic human needs such as food security, safe drinking water and sanitation, and clean air. As a result, the Bank estimates that the health costs of climate inaction could reach at least \$15 trillion by 2050 in low- and middle-income countries (LMICs), equivalent to 1.2 percent projected GDP.

Unabated climate change is also expected to make the global goal of poverty reduction even more challenging to reach. A recent World Bank study estimates that climate change may push an additional 132 million people (more than half of whom live in Sub-Saharan Africa and South Asia), into extreme poverty by 2030, with 44 million of these driven by health impacts. The World Bank is a leading multilateral funder of health systems strengthening, pandemic preparedness and response, and climate investments, with a strong capacity to finance the needed transformation to build climate-responsive, resilient, and equitable health systems. The World Bank has evolved its mission, broadening its goals to emphasize the importance of sustainability and resilience, with support for stronger climate action and pandemic prevention, preparedness, and response. The Bank's new vision is to create a world free of poverty *on a livable planet*, and its new mission is to end extreme poverty and boost shared prosperity *on a livable planet*.

Project background and description of proposed work: The World Bank launched its Global Climate and Health Program (CHP) at COP28 in 2023 to urgently respond to the rising negative health impacts of climate change in LMICs. CHP generates evidence on the most cost-effective interventions to tackle the climate and health crisis; increases financing for solutions that can build sustainable and resilient health systems in client countries; and builds strong partnerships to amplify impact. Specifically, CHP:

- Creates evidence and knowledge to identify country needs and inform investments. This
 includes systematically assessing climate-related health vulnerabilities in developing
 countries, focusing on the impacts on lives, livelihoods, and economies and identifying
 country-specific 'best buys' for climate and health.
- Invests in solutions that are country-tailored and evidence-based and scale-up
 investments for low-carbon resilient health systems through the Bank's more than \$30
 billion health portfolio which is already active in more than 100 countries. Investments
 will focus on better surveillance and early warning systems, improving health service
 delivery in the face of climate-driven disease patterns, climate-proofing health facilities,
 and strengthening health worker capacity.
- Works in partnership with the World Health Organization, The Global Fund, The Green Climate Fund, the Development Banks Working Group for Climate-Health Finance, foundations, private philanthropies and others to maximize impact by supporting global, regional, and country efforts to scale up climate-health action.
