#### NEEDS ASSESSMENT

Celiac disease affect 1% of the population, yet remains a “hidden” and misunderstood disease both in society and the medical profession. Most patients describe a diagnostic delay of 3-10 years before health care providers arrive at the correct diagnosis. Current use of

the duodenal biopsy, serological testing protocols and follow up, as well as the current state of clinical trials have not been adequately disseminated to the medical community, to the detriment of patients.
