Fully Participation (FP), student participated in key aspects of the encounter; **Assisted Participation (AP)**, student was present for the entirety of the encounter and participated in some but not all of the key aspects of the encounter; **Simulation (S)**, key aspects of the encounter using a simulator or standardized patient; **Observed (O)**, student was present for the entirety of the encounter and did not actively participate in the encounter.

Direct Supervision, the supervising physician is physically present with the student and the patient; **Indirect Supervision**, the supervising physician is not physically present with the student and the patient but is immediately available to provide direct supervision upon request, thus requiring that the supervising physician remain physically present within the hospital or other site of patient care. (Being with a student on a Telehealth visit can also count as direct or indirect supervision.)
