U.S. News Rankings

Earlier this week, *U.S. News & World Report* released its annual “America’s Best Hospitals” rankings. While we know that Smilow Cancer Hospital and Yale Cancer Center exceed clinical and research expectations in many ways, we acknowledge that our cancer services ranking does not reflect the incredible dedication, strengths, and innovation from Smilow Cancer Hospital, our Care Centers, and Yale Cancer Center, and the care provided to our patients and their families each day.

The survey uses a three-year rolling average for mortality (2017-2019), discharge to home (2017-2019), and reputation (2019-2021), and includes patient experience survey results for YNHH for the calendar year 2019.

While we pay significant attention to our ranking placement, we recognize that such ranking systems may fail to capture many of the elements of clinical quality, innovation, health equity, and care transformation that are provided by a large matrix academic healthcare system such as ours. Optimizing our performance in this arena is one of many quality initiatives that will continue to be a priority in coming months. We remain fully committed to partnering with our colleagues at Yale New Haven Hospital and Yale Medicine to improve our data scoring in the coming years.

Smilow Inpatient Visitor Restrictions

Effective Wednesday, July 28 our Smilow inpatient units NP 11, 12, 14, and 15 began restricting visitation of all children under the age of 12 because they are not vaccinated for COVID-19. This new policy is in an effort to better protect our immunocompromised patients from increased risk of infection.

COVID-19 Vaccinations

A reminder that all YNHHS and Yale University employees are now required to get the COVID-19 vaccine, with few exceptions for religious or other medical exemptions.

- For YNHHS employees who are not yet vaccinated, you have until August 31 to receive the single dose vaccine (Janssen/Johnson & Johnson) or the first dose of a two-dose vaccine (Pfizer or Moderna). If choosing a two-dose vaccine, the second dose must be administered by September 30. Exemptions will be made for documented medical reasons or religious or spiritual beliefs. Use of Chaperones for Examinations, Treatments, and Procedures

A medical chaperone is a person who acts as a witness for a patient and a health professional during a medical examination, treatment, or procedure. Yale New Haven Health and Yale Medicine have implemented a new policy stating that medical chaperones will be required during sensitive examinations, treatments, or procedures as noted in the policies of the respective entities.

Medical chaperones will also be available during any other examination, treatment, or procedure at the patient's request. Additionally, any member of the care team may request the presence of a chaperone during any examination, treatment, or procedure.

Jade noticed a crowd gathering around and found a man unresponsive and blue; she quickly stepped in and assessed his pulse and began chest compressions while directing others to dial 911 and locate the AED she had seen in the gym. Her calm response, and persistency in requesting the AED and applying it while she directed a witness to continue the compressions is incredible. Jade delivered several shocks and the man



was resuscitated and later admitted to Yale New Haven.

Jade had attended a mock code the week before, and credits her training with helping her know what to do. We are proud of her tremendous skill and leadership in this situation and commend Jade for utilizing her training outside the workplace for our community. We also recognize her manager Cara Henderson and Rebecca Halpern for providing the support and resources for mock codes on their Smilow unit.
