GLIA DESCRIPTION AND INSTRUCTIONS FOR eGLIA

GLIA Background

The GuideLine Implementability Appraisal (GLIA) instrument identifies intrinsic barriers to implementation of a guideline. Implementation refers to that part of the guideline lifecycle in which systems are introduced to influence clinicians' behavior toward guideline adherence. Some guidelines have been found to be more difficult to put into practice than others. GLIA is intended to provide information about a guideline's implementability to:

- A guideline authoring group, which may decide to modify content to improve implementability
- Those individuals who choose guidelines for application within a health care delivery system, in which case, GLIA can be used to anticipate potential problems in implementation.

Implementability is an abstract construct, relating to a number of factors, some of which are intrinsic to the guideline itself—and therefore are under the control of the developers—and some of which are extrinsic. Extrinsic factors are largely site-specific and are beyond the scope of this instrument. GLIA emphasizes a consideration of primarily intrinsic factors, including:

- Executability (exactly what to do)
- Decidability (precisely under what conditions (e.g., age, gender, clinical findings, laboratory results) to do something)
- Validity (the degree to which the recommendation reflects the intent of the developer and the strength of evidence)
- Flexibility (the degree to which a recommendation permits interpretation and allows for alternatives in its execution)
- Effect on process of care (the degree to which the recommendation impacts upon the usual workflow in a typical care setting)
- Measurability (the degree to which the guideline identifies markers or endpoints to track the effects of implementation of this recommendation)
- Novelty/innovation (the degree to which the recommendation proposes behaviors considered unconventional by clinicians or patients)
- Computability (the ease with which a recommendation can be operationalized in an electronic information system) is only applicable when an electronic implementation is planned

Definitions

A conditional recommendation states one or more actions to be performed for members of the target population IF they fulfill one or more stated conditions.

Conditions may include patient descriptors (e.g., age, gender), clinical observations, laboratory results, etc.

Example: If age is greater than 65, the clinician should screen for dementia. In this example, the condition is “age is greater than 65.” The action is “screening for dementia.”

Both and actions may be combined using AND and OR connectors to create complex logical statements.

Example: when the patient manifests dyspnea or tachycardia, treat with a diuretic and monitor vital signs hourly.

An imperative recommendation states one or more actions to be performed for all members of the target population, i.e., the patients eligible for guideline advice.

Example: Assess whether the patient is experiencing pain.

The dimension of executability (questions 10-11) focuses our attention on the recommended action. These questions apply to both imperative and conditional recommendations, as both types of recommendation must contain an action.

The dimension of decidability (questions 12-14) focuses our attention on the conditions of a conditional recommendation. These questions do not apply to an imperative recommendation.

Using GLIA

GLIA questions 1 through 9 (GLOBAL dimension) relate to the guideline document as a whole. It is not uncommon for a single guideline to contain recommendations that vary widely in their implementability. The unit of implementation, therefore, is the individual recommendation, not the entire guideline. The remaining dimensions of GLIA consider recommendations individually.

GLIA users should prepare to use the instrument by selecting those recommendations for which implementation is planned. Note that individual recommendations may contain imperative and/or conditional components.

Some guideline developers issue statements of fact that fail to recommend an action. Such statements are difficult to operationalize and fail executability criteria in GLIA.

Appraisal

It is useful for two or more people to independently score each recommendation. We suggest at least one subject matter expert and one implementation expert should participate.

Appraisers should answer each question with one of the following responses:

Y The recommendation meets this criterion fully.

N The recommendation does not meet this criterion.

? Rater is unable to address this question because of insufficient knowledge or experience in this area

N/A Criterion is not applicable to this recommendation

When any GLIA question is answered as 'N', the reason(s) it fails the criterion should be recorded in the comment section.

Reconciliation

Appraisers should discuss divergent responses in an effort to achieve consensus.

Rating teams should include sufficient expertise to resolve any “?” scores. Questions that are ultimately agreed to be answered as 'N' represent barriers to successful implementation.

Interpretation of Results

An examination of the barriers recorded on the summary report should provide an understanding of impediments to implementation of the guideline statement.

A conditional recommendation that fails any decidability or executability criterion will be impossible to implement as stated.

Likewise, an imperative that fails any executability criterion will not be implementable.

Developers may choose to make modifications to the guideline document before disseminating the guideline. Implementers can target their efforts toward addressing identified barriers.

The new user home page opens. Instructions on using eGLIA are available by clicking on the Instructions button.

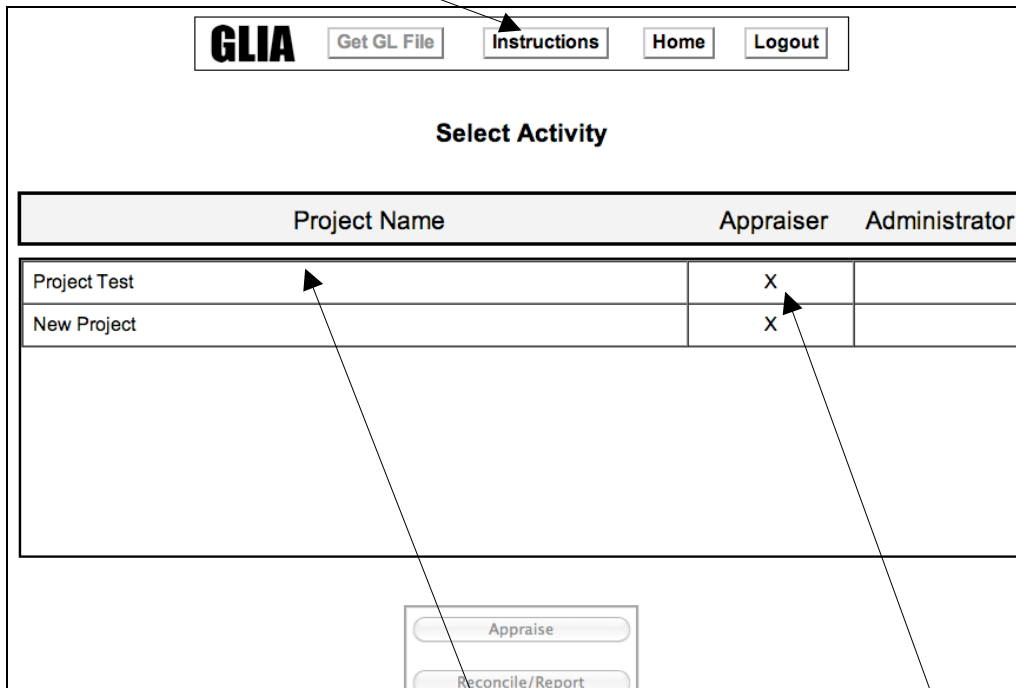


Figure 3: New User Home Page

If you have been invited to appraise a project via the same email you used to register to eGLIA, that project is displayed in the “Project Name” section with your role marked as “Appraiser”.

Administrator: The individual responsible for starting a project in eGLIA, inviting appraisers, reconciling responses and preparing a report.

2. User Home Page: From the home page, select the guideline project you wish to appraise, and select the “Appraise” activity from this page.

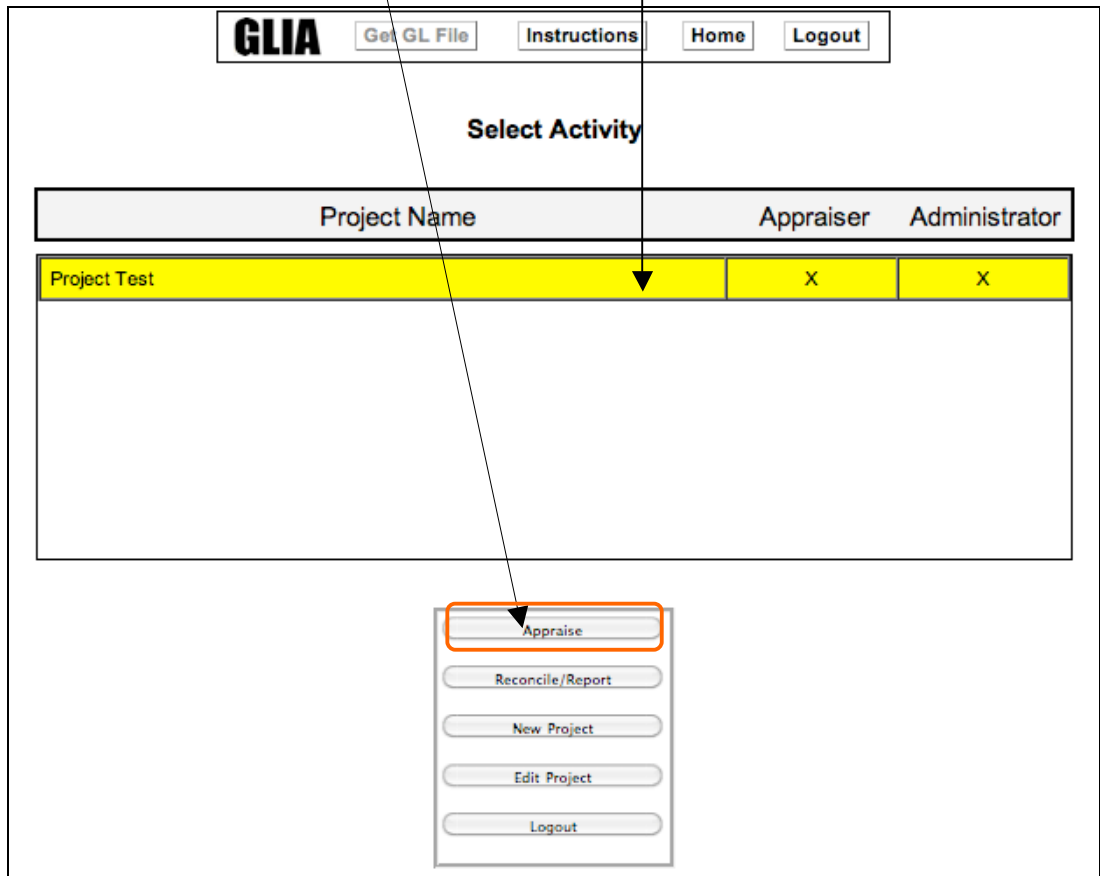


Figure 5: User home page

3. Appraisal Matrix: The next screen displays:

- a. A Toolbar for easy navigation across eGLIA
- b. A matrix of appraisal options for the guideline recommendations. Listed vertically on the left are the individual recommendations by a given name. Horizontally displayed are the GLIA dimensions.

The appraisal matrix displays appraisal progress and allows easy navigation across dimensions and recommendations.

A red bar indicates that all questions in this dimension have not been answered.

A check mark indicates that all questions in this dimension have been answered.

To review responses, click the check mark.

Clicking a red bar opens the dimension for appraisal.

4. Appraising a Dimension: At the top of the work area, the text of the recommendation is displayed.

Below the text recommendation is the Rating Area which displays the GLIA items for the selected dimension and an Appraisal Panel for each item.

The appraiser selects:

Yes, if the recommendation meets this criterion fully.

No, if the recommendation does not meet this criterion

NA, if the criterion is not applicable to this recommendation

?, the rater is unable to address this question because of insufficient knowledge or experience

Reset, to remove a rating.

In addition, a text box allows entry of comments. Users should enter the reason why a No or ? appraisal is selected.

Below the rating area is a **navigation panel**. From here, it is possible to:

- Return to the main menu (appraisal matrix) and assure that your ratings are recorded
- Move to the next (or previous) recommendation to assess the same GLIA dimension, or
- Move on to the next (or previous) GLIA dimension for the same recommendation.

Note: Selected scores are only recorded in the database when the user navigates using this navigation panel (i.e., using the browser's Back and Forward arrows does not record the selection.)

Logout when you are done, or click the "Home" button to return to your home page.

Reconcile/Report

Reconciliation is a critical part of the GLIA process in which variations in appraisals are discussed and resolved. It is intended to be a group activity in which the appraisers participate. Only the Administrator, however, has access to the Reconcile/Report screens.

1. Login to eGLIA (Fig. 4).
2. From the home page, select the guideline project to report and click the Reconcile/Report activity button.

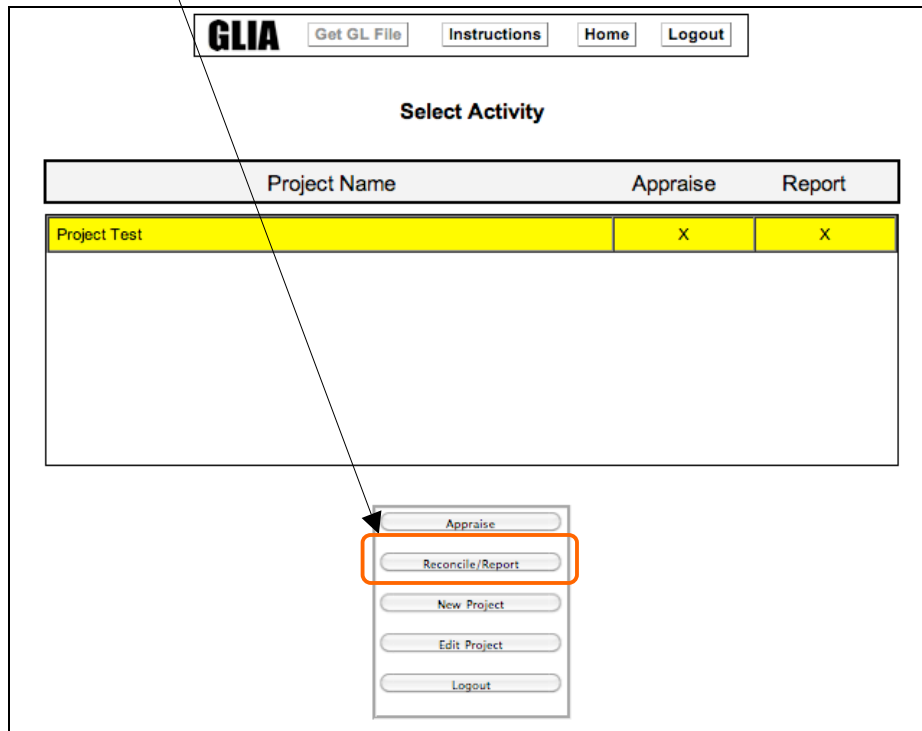





Figure 8: Reconcile/Report Activity for Appraisers

3. **Reconcile Matrix:** Clicking the Reconcile/Report button opens this Reconcile Matrix. Like the Appraisal Matrix, the individual recommendations are listed vertically on the left. The GLIA dimensions are displayed horizontally.

- a.  signify areas requiring discussion because potential barriers may have been identified.
- b.  indicates that all appraisers agreed that the criterion has been met i.e., answered “Yes” to all items in this dimension.
- c.  indicates that a final decision has been entered in eGLIA.

4. Clicking on the red bar opens the Reconcile screen.
5. The administrator, who is preparing the report, reviews the Tally of votes and the group makes a final Decision about whether the criterion has been met. Especially in cases where the criterion is failed, the administrator should indicate in the Final Comments box why the criterion was failed. Individual appraisers' comments are visible and can be retained verbatim or edited.

Recommendation rec 1: Women with uncomplicated breech at 37 to 40 weeks should be offered external cephalic version (ECV) to increase the likelihood of cephalic presentation and vaginal birth.

6. eGLIA reports can be viewed at any time during the reconcile process by clicking the appropriate summary buttons. Reports can be saved or printed.
7. Clicking the “View Summary Report” button opens a new window to display the barriers identified. Items reconciled as “No” are reported as obstacles to implementation.

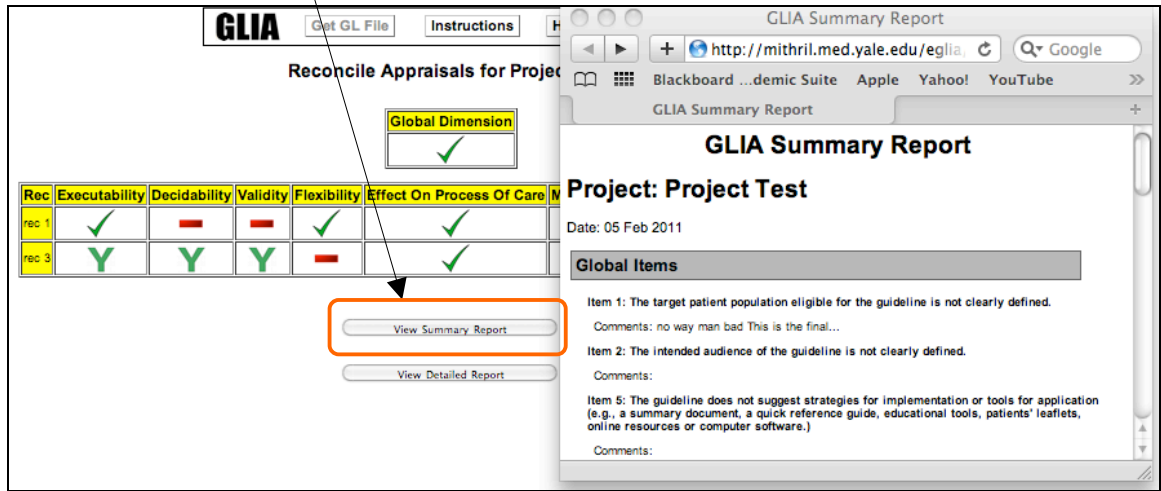


Figure 11: Summary Report in new window can be saved or printed

8. Clicking the “View Detailed report” opens a window to display voting tallies, individual comments, and final comments for all GLIA items.

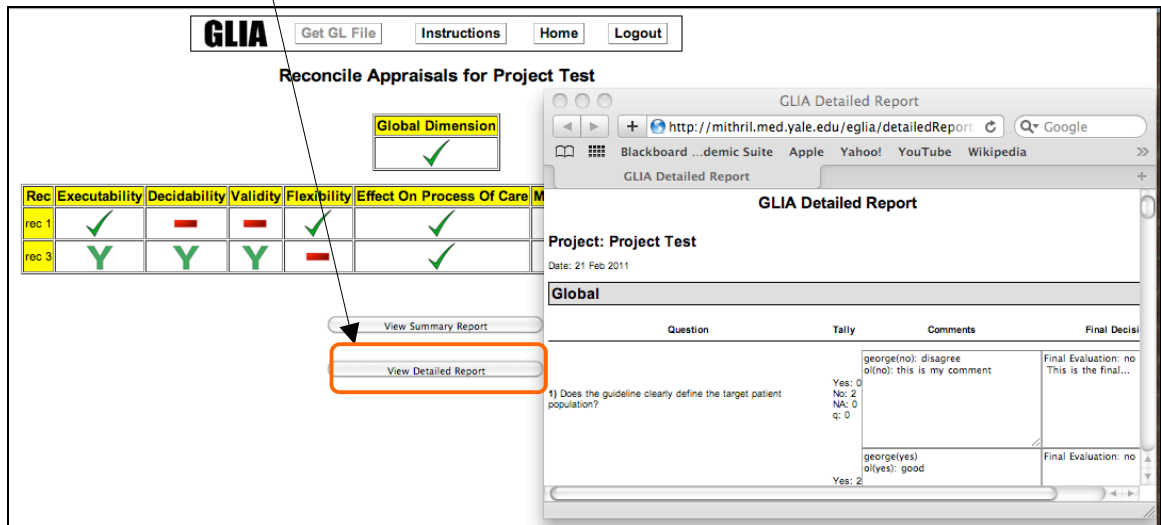


Figure 12: Detailed Report in new window can be saved or printed

New Project

2. From the home page, click on “New Project” button to start a new project.

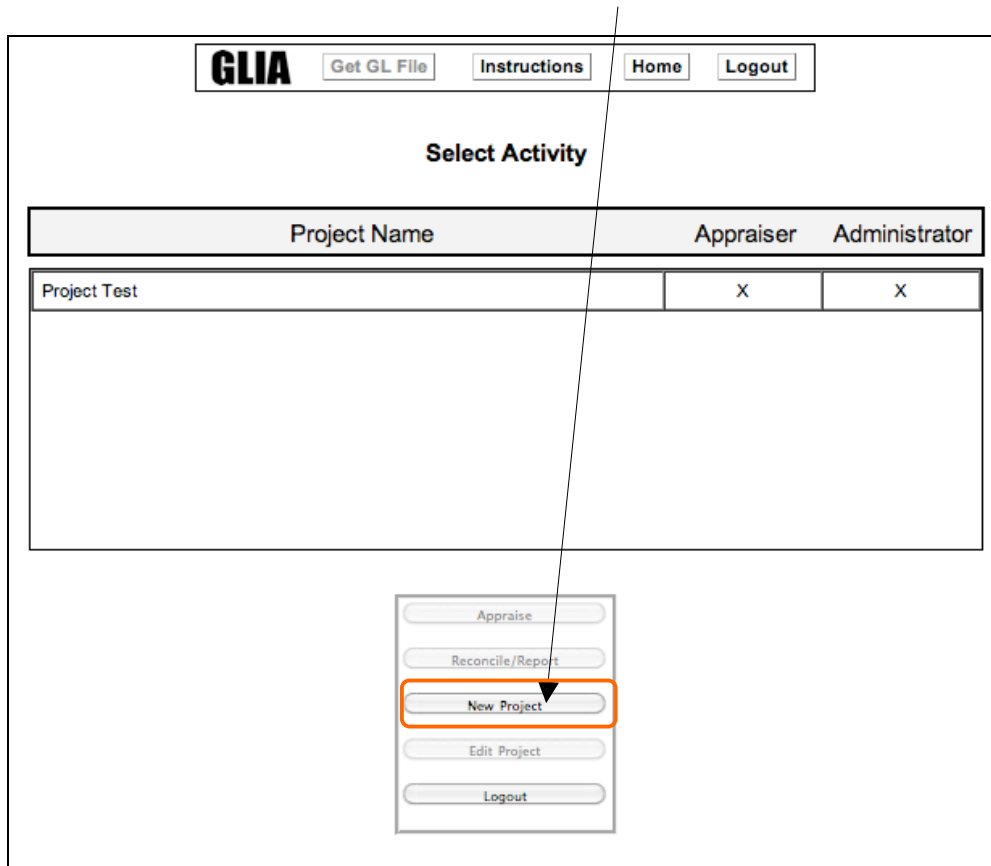


Figure 11: Starting a New Project

4. Name the recommendations and copy and paste the recommendation text.

- The name can be a title (e.g., Diagnosis), a number, or a number followed by a letter. The name must contain fewer than 30 characters.
- The recommendation text should be identical to the recommendation in the print guideline and should not include supporting text.

5. To add another recommendation, click the “Add a Recommendation” button. When all the intended recommendations have been entered, click the “Proceed to add Appraisers” button.

6. Enter email addresses of all the appraisers, separated by commas. When you click the “Complete Setup” button, an email will be sent to the appraisers providing a brief explanation about eGlia and instructions for registering.

Edit Project (for administrator's only)

1. Login to eGLIA (Fig. 4).
2. From the home page, select the project you wish to edit and the “Edit project” activity.

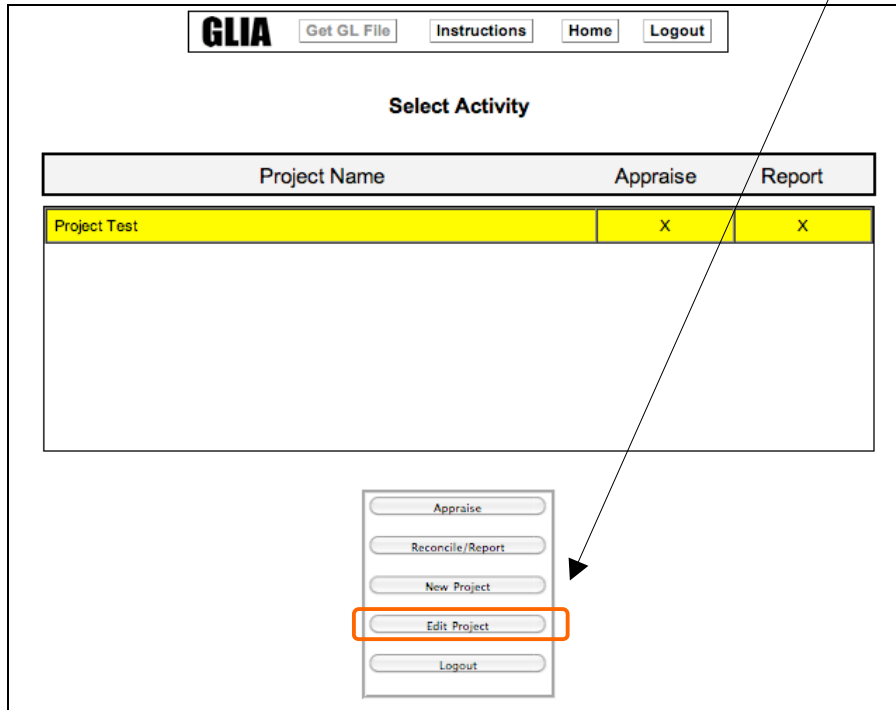


Figure 15: Edit an existing project

3. An administrator may modify general project information, add or modify recommendations, edit appraisers, or change the status of an existing project. Click the desired activity and proceed as below.

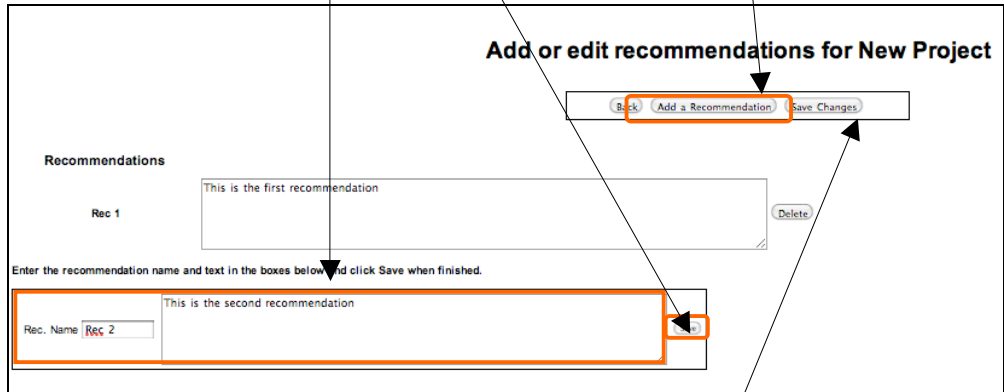


Figure 18: Add Recommendation or edit an existing recommendation

- b. Add a Recommendation: Click the edit button under “Recommendations” and proceed to add, or change recommendations (Fig.18). Clicking on “Add a recommendation” button opens a new recommendation box. New recommendations are appended at the end of the current list. Click the “Save” button to save the added recommendation.

To change an existing recommendation, edit the text of the recommendation and click “Save Changes” button.

- c. Edit appraisers: Add new appraiser(s) by entering their email addresses separated by commas. Revoke access to any appraiser by checking the button next to “Revoke access”. Proceed to save the changes made by clicking “Save”.

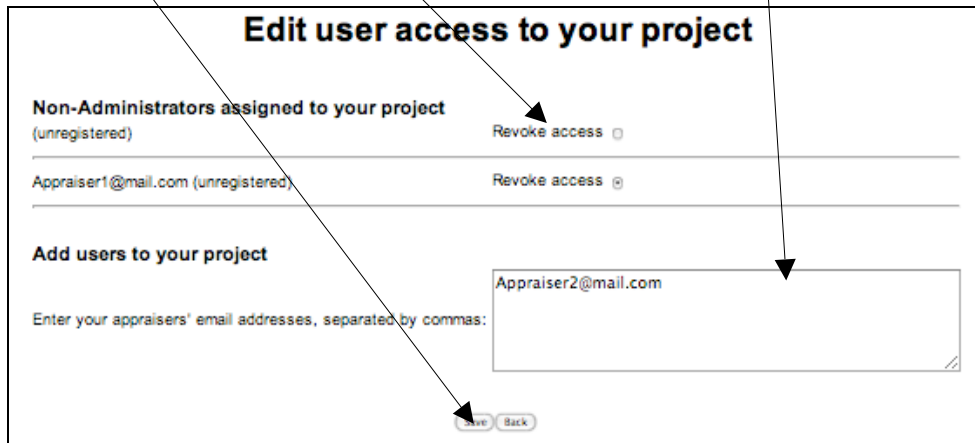


Figure 19: Edit appraiser access or add new appraisers

- d. Inactivate and Reactivate project: An inactive project cannot be appraised. Reactivating a project makes it available to appraisers again. Click the “Inactivate?” link in Figure 18 and follow the instructions on the next screen.
