COVID-19 Update: May 1, 2020

Dear Colleagues,

#### **Smilow COVID+ Patients**

Smilow Cancer Hospital currently has 378 COVID+ patients identified within our care, 41 of whom are hospitalized. The remaining patients are called on a daily basis, 7 days a week, by our nurses to check on their symptoms, and to ensure they are getting the care and resources they need.

- This nurse-driven care delivery system is proactively intervening to reach out to our patients at home and provide them with education and support. When necessary, issues are triaged or escalated to the covering provider.
- 15 nurses are participating in the program and making an average of 18 calls per day. Over a recent three-day period, 335 patients were called. We are expanding the number of staff making calls to ensure all patients are called daily.
- Referrals have been made to Telehealth, social work, the Smilow Rapid Evaluation Clinic, and local Emergency Rooms.

# **Social Work and Support Groups**

Over the last month, our social work team has transitioned most of our support groups to a virtual format. The engagement from our patients and families has been tremendous, with an increase in participation, and excellent feedback from participants.

- The department of social work offers <u>21 Support Groups</u>, many of which are focused on specific cancer types, spouses and caregivers, or are focused on a specific delivery area within the Smilow Network.
- Bereavement services are also available for our patients, and have been expanded
  during this challenging time to offer <u>virtual opportunities and seminars</u> for support to
  anyone in the health system and community.
- Individual referrals to social work should still be considered, as needed. Social
  workers are available to consult with patients by phone or through other video
  communications. Please engage with the social worker assigned to your program,
  or call (203) 688-2195 for assistance.


## Save the Date
