NEEDS ASSESSMENT

The annual incidence for Idiopathic inflammatory myopathies is about 2-19 cases/million, and this group of diseases is characterized by proximal muscle weakness, elevated muscle enzymes, abnormal electromyogram and muscle biopsy. There are various subsets within a broader term of idiopathic inflammatory myopathies, each with unique clinical features, autoantibodies and pathogenesis. In this talk, we will discuss updates on diagnostic and prognostic testing as well as treatment options and outcomes for patients with idiopathic inflammatory myopathies.
